- 1. (a) The "UOB Visa Amazon.com Cashback" promotion ("Promotion"):-

(a) The Qualifying Spend Amount will be determined based on date that the Qualifying Spend is posted and captured in UOB's system as an amount either equivalent to or more than SG\$155 (at a fixed exchange rate of 1.24). Only Qualifying Spend that is posted and captured in UOB's system within the Promotional Period will be valid. Any Qualifying Spend charged by the supplementary Selected Cardmember(s) will also be taken into consideration for the Promotion. UOB will not be liable for any late transaction postings affecting any Selected Cardmember's eligibility to qualify for the Rewards.
 - (b) The term "Qualifying Spend" shall mean all Amazon.com transactions (in US currency) successfully carried out on and charged to the UOB Visa Card and which are successfully posted and captured in UOB's systems.

Each Eligible Cardmember who qualifies for the Rewards will receive the Rewards credited to his/her UOB Visa Card account by 28 February 2015 in Singapore Dollars (SG\$) at a fixed exchange rate of 1.28.

General Terms and Conditions for US\$12.50 Cashback
