- Available from Monday to Friday (excluding Public Holidays).
- Your approved UOB Supplementary Card(s) will be couriered to the Principal Cardholder's address as per bank records.
- If courier is unsuccessful, the credit card will be mailed out to the same address on the next business day.
- The courier service fee of S\$10 will be charged to the Principal Card in the next card statement.
