

TRAVEL REVOLUTION 2016 Gift Redemption and Sure-win Lucky Dip Terms and Conditions

- TRAVEL REVOLUTION 2016 Gift Redemption and Sure-win Lucky Dip ("Promotion") are valid only for new bookings/purchases made by the Eligible Cardmembers at TRAVEL REVOLUTION 2016 from 26-28 February 2016 ("Promotion Period").
- "Eligible Cardmembers" shall mean all principal UOB Credit and Debit Cardmembers holding UOB Credit and Debit Cards (collectively referred to as "Cards" and each a "Card") which is valid, subsisting and in the opinion of UOB in good standing and satisfactorily conducted while "Eligible Cardmember" shall mean any one of them.

- (b) The "Sure-win Lucky Dip" wherein each Eligible Cardmember are entitled up to a maximum of five chances to enter the UOB Sure-win Lucky Dip per Eligible Cardmember per NRIC per day, with minimum spend of \$\$800 in a maximum of 3 receipts, to win a lucky dip prize ("Prize") while stocks last.
- Limited to one redemption tier per Eligible Cardmember per NRIC per day. Only same day booking/ purchases made at TRAVEL REVOLUTION 2016 are eligible for the Promotion.
