

Terms and Conditions governing the [UOB Visa / UOB Visa Infinite] Credit Card Spend with Singapore Airlines

Terms & Conditions: The United Overseas Bank Limited (“UOB”) SIA-VISA Business Class Special for Two promotion (“Promotion”) is open to all UOB Visa Credit/Debit cards issued in Singapore. The Promotion is exclusive to UOB Visa cards from 1 October to 12 October 2014 and applicable to all Visa cards from 13 October to 30 November 2014 (“Promotion Period”). Full payment must be made with [UOB Visa Credit/Debit cards]. The Promotion is not valid with other on-going promotions, discounts, vouchers and other privileges.

Travel Terms & Conditions: Advertised fares include taxes and surcharges which are subject to currency fluctuations. Advertised fares are available for purchase during the Promotion Period, subject to seat availability and flight restrictions. Fares are per person in Business Class for return travel out of Singapore from 1 November 2014 to 28 February 2015 (“Travel Period”). Travel must complete by 28 February 2015. A minimum of 2 passengers must travel together on the entire itinerary for the Promotion to apply. A 7-day advance purchase prior to departure out of Singapore is required. Tickets are not interchangeable for travel on other airlines. Changes outside of the terms and conditions will result in additional charges. Merchant terms and conditions apply. Cash Rebates for UOB Visa Infinite, Privilege Banking or Reserve Cardmembers: The first 200 qualified Principal and/or Supplementary cardholder of a UOB Visa Infinite, UOB Privilege Banking or UOB Reserve card (“Cardmember”): (i) with the highest accumulated spend of a minimum of two (2) Singapore Airlines air tickets on their UOB Visa Infinite, UOB Privilege Banking or UOB Reserve Card based on the earliest posting date during the Promotion Period; and (ii) book through UOB Travel Planners Pte Ltd, will qualify for a S\$300 cash rebate (“Gift”).
