

UOB PayNow Corporate Introductory Offer (Incoming Transfers) Terms & Conditions

1 Definition

‘**Customer**’ means both an Eligible Customer and a Participating Customer or both as the context may require.

‘**Eligible Customer**’ has the meaning in Clause 2.1.

“**Participating Customer**” means an Eligible Customer who signs up for the Promotion and whom UOB agrees to offer the Promotion to.

“**Promotion**” means this UOB PayNow Corporate Introductory Offer.

“**Promotional Period**” means 13 August 2018 to 31 December 2019 (both dates inclusive).

“**Terms and Conditions**” means the terms and conditions for this Promotion, as may be amended from time to time.

“**UOB**” means United Overseas Limited.

“**UOB Account**” means the UOB SGD Currency Current Account stated in the application form for the purposes of the Promotion.

2 Eligibility

2.1 The Promotion is extended to eligible corporate customers (“**Eligible Customers**” and each an “**Eligible Customer**”) of UOB.

2.2 To be a Participating Customer, the Eligible Customer is required to be a successful registrant of PayNow Corporate.

2.3 UOB has the sole and absolute discretion to determine the eligibility of the Eligible Customers. Such determination shall be final and conclusive and UOB is not obliged to provide any reason.

3 The Promotion

3.1 Enjoy fee waiver on all incoming PayNow Corporate transactions to UOB during the Promotional Period.

4 General

- 4.1 The decisions of UOB on all matters relating to the Promotion are final, conclusive and binding. UOB shall not be obliged to give any reason or enter into any correspondence with any person on any matter concerning the Promotion.
- 4.2 The Customer represents and warrants that all information provided by the Customer to UOB, including but not limited to all information provided in the application form for the Promotion, is true, accurate and complete and if there is any change in such information, the Customer will immediately update UOB in writing. This representation and warranty shall be deemed repeated on each date for as long as the Promotion is offered by UOB to the Customer.
- 4.3 UOB reserves the right at any time in its absolute discretion to amend or vary any of the Terms and Conditions or any part of the Promotion, without prior notice, including but not limited to the eligibility, terms and criteria, the timing of any act to be done, the Sign-up Period and the Promotional Period, and all Customers shall be bound by such amendments.
- 4.4 UOB reserves the right to withdraw or terminate the Promotion at any time without notice.
- 4.5 UOB shall not be liable to any person for any loss or damage arising in connection with the Promotion.
- 4.6 In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Promotion, these terms and conditions shall prevail.
- 4.7 Participating Customers will be subjected to the terms and conditions of UOB's Terms and Conditions Governing Accounts and Services, Additional Terms and Conditions Governing Accounts and Services, UOB Privacy Notice (Corporate), PayNow Corporate Terms and Conditions and other terms and conditions governing the UOB Account, including any amendments, variations or supplements thereto.
- 4.8 These terms and conditions shall be governed by and construed in accordance with the laws of Singapore, and all Eligible Customers shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
