## TERMS AND CONDITIONS FOR UOB DEBIT CARD WATERBOMB 2024 PROMOTION

- 1. This UOB Debit Card WATERBOMB 2024 Promotion (the "**Promotion**") is valid from 24 June 2024 to 5 August 2024 (both dates inclusive) (the "**Promotion Period**").
- 2. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 3. To participate in this Promotion, you must satisfy all of the following conditions: -
  - (a) you must be an existing holder of a UOB One Debit Visa Card or UOB One Debit Mastercard Card issued by United Overseas Bank Limited ("**UOB**") in Singapore ("**UOB One Debit Card**") and an individual who is currently enrolled as a student in the Singapore Polytechnic; and
  - (b) you must successfully charge a total of at least S\$300 in Eligible Transactions to your UOB One Debit Card during the Promotion Period.
- 4. The following persons shall not be eligible to participate in this Promotion:
  - (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;

  - (e) Transactions charged to the UOB One Debit Card in foreign currencies will be converted into Singapore dollars based on UOB's then prevailing exchange rate applicable at the time of exchange.

## General

- 15. - 21. - 22. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce the Terms.
- 23. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
