



**TERMS AND CONDITIONS GOVERNING**  
**LAZADA-UOB CARD – ONE YEAR FREE REDMART MEMBERSHIP ACQUISITION**  
**PROMOTION FROM 1 OCTOBER 2024 UNTIL 31 DECEMBER 2024**

**1. Promotion**

- 1.1. This Lazada-UOB Card One Year Free RedMart Membership Acquisition Promotion (the “**Promotion**”) is valid from 1 October 2024 until 31 December 2024, both dates inclusive (the “**Promotion Period**”).
- 1.2. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the “**Terms**”).
- 1.3. This Promotion is only open to individuals who are new to United Overseas Bank Limited (“**UOB**”) Lazada-UOB card as described in Clause 1.4(a) below.
- 1.4. To participate in this Promotion, you must satisfy all the following conditions:
  - (a) you must not be an existing principal cardholder of Lazada-UOB Card in Singapore at the time when your Application (as defined below) under this Promotion is approved and you cannot have cancelled any Lazada-UOB Card of which you were the principal cardholder, within six (6) months prior to the commencement of the Promotion Period;
  - (b) you must successfully submit an application for a new Lazada-UOB Card issued by UOB in Singapore (“**Card**”) as principal cardholder during the Promotion Period (the “**Application**”); and
  - (c) your Application must be approved by UOB during the Promotion Period.
- 1.5. UOB has the right at its discretion to approve or decline any Application and is neither obliged to give any reason or prior notice on any matter concerning the Application nor be liable to any party.

**2. One-year free RedMart Membership**

- 2.1. If you satisfy all the conditions in Clause 1.4 above, you shall be eligible to receive a one-year subscription of RedMart Membership (“RedMart Membership”) for free.
- 2.2. If you are eligible to receive the RedMart Membership, the unique voucher code will be sent to your bank registered mobile number within 60 days following the date of card approval (or such other date as may be determined by UOB in its sole discretion).
- 2.3. The benefits from RedMart Membership is valid for transactions made on RedMart using Lazada-UOB Card only.
- 2.4. If your Card account is not validly subsisting and in good standing, is closed, terminated and/or suspended for any reason whatsoever during the Promotion Period or before any Redmart Membership under this Promotion is sent to your bank registered mobile number, you will not be entitled to receive any such reward.
- 2.5. You are only entitled to redeem one RedMart Annual Membership under this Promotion.
- 2.6. The RedMart Annual Membership is not exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost, damaged or stolen. No reservation, refund or exchange of the RedMart Membership Gift is allowed.



- 2.7. UOB may substitute the RedMart Annual Membership with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.8. The RedMart Annual Membership is supplied by third party merchants and UOB is not an agent of the merchant and/or supplier of the RedMart Membership. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the RedMart Membership and UOB assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the RedMart Annual Membership. Any dispute regarding the RedMart Membership is to be resolved directly with the merchant/supplier. UOB shall not be required to assist or act on your behalf in communicating with the merchant/supplier. For the purposes of this clause, "RedMart Membership" includes any products and/or services provided by third party merchants/vendors in connection with the use and/or redemption of the RedMart Membership.
- 2.9. Use of the RedMart Annual Membership remains subject to the prevailing terms and conditions imposed by the merchant and/or supplier of the RedMart Membership (or such other terms and conditions which the merchant and/or supplier may impose subsequently in its sole discretion), which shall be your sole responsibility to comply with.

### **3 General**

- 3.1 The following persons shall not be eligible to participate in the Promotion:
  - (a) individuals whose UOB account(s) is/are delinquent, voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
  - (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
  - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them;
  - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time; or
  - (e) individuals who have participated in any other UOB credit card acquisition promotion during the Promotion Period.
- 3.2 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with your participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third-party applications, howsoever caused.
- 3.3 UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any



reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.

- 3.4 The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement, the Terms and Conditions Governing the Lazada-UOB Card and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.5 UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.6 Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.7 By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for all purposes in connection with this Promotion and to contact you, including by voice call or text message.
- 3.8 A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce the Terms.
- 3.9 The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
