TERMS AND CONDITIONS FOR GET S\$5.80 CASHBACK ON COMFORTDELGRO TAXI RIDE WITH SCAN TO PAY ON UOB TMRW

1. Eligibility

- 1.1. This Get S\$5.80 Cashback on ComfortDelgro Taxi Ride Promotion (the "**Promotion**") is valid on 9 August 2023 and every Friday thereafter on 11, 18, 25 August and 1, 8, 15, 22, 29 September 2023 (each a "**Qualifying Date**" and collectively, the "**Promotion Period**").
- 1.2. By participating in this Promotion, you are deemed to have agreed to be bound by these terms and conditions governing the Promotion (the "**Terms**").
- 1.3. To participate in this Promotion, you must satisfy all of the following conditions ("Eligible Customer"):
 - a) be an existing United Overseas Bank Limited ("**UOB**") customer with a personal UOB savings account or current account ("**Account**") held by you as the primary accountholder, and in each case, such Account must be valid and in good standing and conducted in a proper and satisfactory manner at all times (as determined by UOB in its sole and absolute discretion).
 - b) you must be among the first 40,000 rides during the Promotion Period to successfully make the payment for your ComfortDelgro taxi ride of any amount by scanning the NETS QR Code on the payment terminal from ComfortDelgro taxi, using the Scan-to-pay function on UOB TMRW app.
- 1.4. Each Eligible Customer is entitled to enjoy a maximum of S\$5.80 (the "Cash Credit") cashback on their ComfortDelgro taxi ride on each Qualifying Date. For the avoidance of doubt, each Eligible Customer can receive a maximum of nine (9) Cash Credits during the Promotion Period.
- 1.5. Eligible Customers who successfully fulfill the conditions set out on clause 1.3 above shall receive the Cash Credit into their Account (which shall be the same Account from which the qualifying transaction was made).





1.6. Cash Credit awarded under this Promotion will be credited within one month from date of transaction. You are responsible for ensuring that your UOB account is valid and existing, not blocked from use, in good standing and conducted in a proper and satisfactory manner (as determined by UOB in its sole discretion) at the time of crediting. UOB shall not be responsible for any loss or damage suffered by any person if the Cash Credit is not credited or available for use, or if you are unable to redeem or use the said Cash Credit.

2. GENERAL

- 2.1. Cash Credits will not be credited to the Eligible Customer if his/her UOB account is suspended, closed or terminated on or before the date on which the Cash Credit is to be made.
- 2.2. Cash Credits are neither transferrable nor exchangeable for other cash, credit, goods and services, products or privileges or other kind in full or in part and is not refundable or replaceable. UOB reserves the right to replace the Cash Credit with another item of similar value without giving any reason or prior notice or assuming any liability to any person.
- 2.3. Notwithstanding anything to the contrary, UOB reserves the right to select a substitute Eligible Customer/Account to substitute an initial Eligible Customer/Account that is subsequently found to be ineligible or disqualified or not entitled to participate in this Promotion.
- 2.4. If any Eligible Customer/Account is subsequently found to be ineligible or disqualified or not entitled to participate in this Promotion, UOB reserves the right to, without prior notice or having to give any reason, forfeit/reclaim the Cash Credit and award or dispose of it in such manner and to such persons as UOB deems fit without any liability on the part of UOB to any persons. No payment or compensation whether in cash, credit or kind shall be made by UOB for the forfeited/reclaimed Cash Credit. UOB shall also be entitled to claim from any Account a reimbursement for the value of the Cash Credit through such modes and methods as shall be determined by UOB, including, without limitation, deducting/claiming back the same from any of the Eligible Customer's accounts with UOB or otherwise.
- 2.5. The following persons shall not be eligible to participate in the Promotion:
 - a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or





- d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 2.6. UOB shall not be responsible or liable:
 - a) for any losses, damages or otherwise suffered by any person if it is unable to perform its obligations under the terms and conditions of this Promotion due directly or indirectly to the failure of the merchant establishments, merchant acquirer, telecommunication authorities or service provider or such other third party which may be engaged or whose services are relevant to this Promotion, any machine or communication or computer system, industrial dispute, war, Act of God, or anything outside the control of UOB;
 - b) for any application, notice or communication, email which gets lost, misplaced, defaced, tampered with, stolen, damaged or misdirected;
 - c) for any breakdown or malfunction in any computer system or equipment; or
 - d) for any costs, losses, damages, claims, expenses and/or injuries of any customer or any other person howsoever incurred or suffered.
- 2.7. UOB may, at any time and from time to time, terminate or withdraw this Promotion and/or vary, modify, add and/or delete any provisions herein, including but not limited to amending the duration of this Promotion or the eligibility criteria, without giving any reason, prior notice and/or assuming any liability to any party, and UOB shall not be liable to pay any compensation or enter into any correspondence in connection with the same and all Eligible Customers shall be bound by any such variations, modifications, additions and/or deletions.
- 2.8. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with this Promotion and UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter relating to this Promotion. UOB's decisions on all matters in connection with this Promotion are at its discretion and shall be final, conclusive and binding on all parties concerned and no payment or compensation will be given or paid by UOB to any person.
- 2.9. All Eligible Customers shall continue to be bound by:
 - (i) UOB Debit Cardmember Agreement;
 - (ii) UOB Terms and Conditions Governing Accounts and Services;
 - (iii) UOB Debit Card Fees and Charges;
 - (iv) NETS Terms and Conditions; and
 - (v) Terms and Conditions governing Digital Services.

In the event of any inconsistency between these Terms and Conditions and the aforementioned terms and conditions, these Terms and Conditions shall prevail to the extent that such inconsistency pertains to this Promotion. In the event of any





inconsistency between these Terms and Conditions and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms and Conditions shall prevail to the extent that such discrepancy relates to this Promotion.

- 2.10. All information is correct at the time of publishing or printing and UOB makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy. In the event of any inconsistency or discrepancies between these terms and conditions and any advertising, publicity, brochure, marketing or promotional material or other materials relating to or in connection with this Promotion, these Terms and Conditions shall prevail.
- 2.11. Unless otherwise stated, the Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions.
- 2.12. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
- 2.13. A person who is not a party to these Terms and Conditions has no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce any term herein.
- 2.14. These terms and conditions shall be governed by and construed in accordance with the laws of Singapore and the Singapore courts shall have exclusive jurisdiction over any dispute arising out of or in relation to the Promotion.
